H. Diabetes Virtual Nurse Project

G Damgaard reported the Virtual Nurse Project for School Children with Diabetes is completed as of the end of the 2012-2013 school year. Results will be published and the manuscript is completed. G Damgaard expressed gratitude to the National Council State Boards of Nursing (NCSBN) and the SD Department of Health for their financial support of the project. She also expressed gratitude to

NCSBN for providing a statistician for analysis of the data. Results of the clinical outcome data and the pre and post survey data support this model of nursing delegation as safe, including the delegation of insulin administration.
