November 1-2 2007 Board Meeting – The Minutes were approved as presented in a unanimous voice vote.

November 27-28, 2007 Strategic Planning Meeting – First page, second bullet, add one BOME "actively licensed physician" – The Minutes were approved with that correction in a unanimous voice vote.

December 10, 2007 Teleconference – The Minutes were approved as presented in a unanimous voice vote.

FINANCIAL REPORTS – Robert Garrigan presented a six month review based on handouts previously distributed. MOTION: John Jones moved that the South Dakota Board of Nursing accept the financial report.

- The GOAC Report and HB1107, an act to set license fees, etc. were discussed. Amendments were made to SDCL 36-9; fee structure is to be set in rules, which has long been the policy for this Board, so changes are minimal for this Board. Hearings are being held with those boards which were negatively impacted to add amendments to the bill.
- CNA YEAR-END REPORT Nancy Bohr summarized the written report. A total of 263 more active CNAs are registered at the end of 2007 as compared to 2006. There have been decreases in endorsements and equivalencies. Most CNAs are now renewing online. Approval for four CNA training programs was withdrawn this year due to deficiencies found by South Dakota Department of Health.
- NCSBN POLICY PERSPECTIVES Gloria Damgaard presented. Specific items discussed included "Congress targets diploma mills" and the House of Delegates regarding Advanced Practice Nursing. It was also noted that Wisconsin and Iowa schools of nursing are preparing more nurses with higher-level education.
- CITIZENS ADVOCACY CENTER REPORT This report was provided to Board Members for their review. The CAC will convene May 12-13, 2008 in Washington, DC.
- NCLEX REPORT 4TH QUARTER 2007 was combined with the Annual Report of Nursing Education Programs.
- SOUTH DAKOTA CENTER FOR NURSING WORKFORCE Report Linda Young, Director of the SDCNW, presented based on the written report that had been distributed earlier.
- INSTITUTE OF REGULATORY EXCELLENCE Linda Young and Nancy Bohr attended. L. Young said that the speakers provided worthwhile information and strategies concerning future practice, regulation, building coalitions, networking, foundations for the future, and scope of practice. A speaker from North Carolina reported that they are working with facilities to develop a grid prioritizing reportability of medical errors, etc. N. Bohr is working on a feasibility study regarding oversight of Medical Assistants.
- NCSBN 2008 NOMINATIONS Nancy Bohr will run for the Succession Committee for Area II. This Board expressed its encouragement, and will furnish a letter of support.
- PUBLISHING CONCEPTS INCORPORATED has announced a nursing scholarship program for students, in the amount of \$3,000 \$5,000 per state. The scholarships will probably be disbursed as awards of \$1,000 per student. G. Damgaard will notify PCI of South Dakota's interest in participating, with PCI administering the program and selecting the recipients.
- SYSTEMS AUTOMATION PROJECT G. Damgaard presented an update. Both the South Dakota Board of Medical and Osteopathic Examiners and NCSBN are also exploring new systems; compatibility among databases is being taken into consideration. The Iowa Board of Nursing, which uses IFMC, now has the source codes; a group of IT people has made small improvements to the IFMC database and are maintaining it; this group has approached this Board with a similar proposal.
- STRATEGIC PLAN Gloria Damgaard reviewed the formatted written plan. The Strategic Initiatives center around 1) quality of practitioner, 2) quality of care, and 3) quality of education. More input is sought to help develop these initiatives and their respective outcomes.
- ANNUAL REPORT OF NURSING EDUCATION was presented by Nancy Bohr. Some new developments were discussed; for example, Pharmacology has been established as a separate course within some curricula. Published statistical reports were distributed and reviewed in a power point presentation. It was noted that more distance students via online courses may help to account for the lower percentage of graduates who become licensed in this state. Suggestions for improving pass rates were discussed; a conference on the topic is being considered by the SDCNW Governance Council and by NEDDS, Margot Nelson, Chair. Linda Burdette of Presentation College said that their NCLEX ADN and Fairmont reports show in what area(s) the students need more work. G. Damgaard said that as part of the Board's Strategic Plan, an Education Council is to be formed that will involve educators.

2008 LEGISLATION – Gloria Damgaard and Kris O'Connell presented.

- SB34, the CNM bill sponsored by South Dakota Department of Health as an Agency Bill, has passed the Senate, and the House Hearing Committee gave it a "do pass." A hearing is to be held in the House.
- HB1155, which would allow independent practice for lay midwives, will be under consideration in the upcoming week. The South Dakota Department of Health is opposed to this midwife bill.
- HB1152 School nurses and the Department of Education opposed this bill dealing with administration of insulin injections for students with diabetes. The bill was killed. Diabetes educators may establish a task force in preparation for the next legislative session. SDNA has opposed the bill as well.

PRESENTATION COLLEGE – ACTION PLAN for NCLEX® Pass Rates. Nancy Bohr presented. Linda Burdette, Director, said that analysis of the data regarding 2006 and 2007 graduates is being conducted to discover where the "holes" in education may be. Faculty numbers are up this year compared to last year; only one person is in overload. The program has support from administration. Avera partners from the northeast part of the state have asked the college to participate in SEED II. (SEED was accomplished through a grant from the Department of Labor.) L. Burdette said that they are holding information sessions in towns over northern South Dakota to determine the level of interest; a minimum of thirty would be required. This is to be funded by the student, although Avera may offer some scholarship. The program at Presentation College is being reorganized and it is anticipated that they will have a proposal ready by the April Board meeting.

THE BOARD MOVED INTO OPEN SESSION

Scope of Practice – Authorization of Refills by RNs: Linda Young presented. Rita Haxton, Vice President of Patient Care at Rapid City Regional Hospital, has submitted a written request for clarification regarding the issue of nurses authorizing refill prescriptions in the recurring outpatient (Hemodialysis) setting. R. Haxton states in her request, "It is my understanding that the nurse in the Outpatient Dialysis setting could authorize a prescription refill if:

- The physician has ordered that authorization to refill prescriptions each time the treatment protocols are renewed and signed by the physician (every 6 months)
- The physician has ordered that refills can be authorized from the current medication list or medications listed in the physician progress notes.

A pharmacist who was consulted regarding this issue said that there is a letter on file at the Board of Nursing that authorizes this practice. The consensus of the Board, however, is that, according to statute, this task is not within the nurse's scope of practice; G. Damgaard will send a response to that effect to R. Haxton.

SDSU COLLEGE OF NURSING REFRESHER COURSE: Nancy Bohr presented a recommendation for re-approval of both the RN and LPN program refresher courses. Within the enrollment in the online program, 28 states are represented; 11 RNs and 8 LPNs were returned to practice in South Dakota last year through these programs.
