

**South Dakota Board of Chiropractic Examiners Meeting**  
**Teleconference**  
**December 5, 2018**

The board meeting was called to order at 1:30 p.m. central time. Roll call was taken and the following members were present: Dr. Kathleen Deutsch, Dr. Rick Odland, Dr. Jeff Kramer, Dr. Bill Blickensderfer and Bev McCracken along with Marcia Walter, Executive Director. Dr. Bruce Albrecht was also on the conference call.

M/S McCracken/Kramer to approve agenda as presented with no additions or corrections

M/S Blickensderfer/Odland to approve secretary's report from September 12, 2018 meeting  
*Passed, no opposition*

Marcia Walter presented the financial update. The state account currently has a balance of \$340,626.32. Renewal notices were mailed November 5 and about 30% of renewal payments have been received to date.

Marcia Walter reported that there haven't been any peer reviews received since last meeting. No further action taken.

Dr. Odland, investigative officer, presented the investigative report.

Marcia Walter presented board executive director report. Licensee update as of 11/29/18: Active DC's – 450; Inactive – 76; CA's 271; X-ray techs – 63. New board member training was held with Dr. Jay Ortman who will join the board Jan. 2, 2019. Information was shared regarding potential draft legislation being written by various groups regarding professional and occupational licensure by endorsement for active military personnel and military spouses. As this progresses, the board will be asked for a formal opinion but no action needed at this time as the discussion was information only.

Dr. Deutsch shared up dates from the recent FCLB District meeting in California. Some topics of discussion from the meeting that stood out consisted of - CARE credit; pastoral medicine, opioid epidemic, passenger stuffing scam, stem cell treatment, CBD problems in several states, passport licenses, NBCE Spec exam now available at various testing centers.

The board reviewed a letter received from student Jarod Franklin requesting consideration and

subsequent approval of a preceptor doctor for his preceptorship which would begin October 2019.
