1. **Call to Order** – N Nelson, Board President called the Public Hearing to order at 1:03 PM and outlined the procedure to be followed to consider proposed changes to **ARSD Chapter 20:48:01, 20:48:06, 20:48:07, 20:48:15 and Article 20:62.**
2. N Nelson, presented an overview of the proposed rule changes.

Time was allowed for all written testimony submitted regarding proposed rule changes be read into testimony. G Damgaard responded that no written testimony was received by the Board on the proposed changes to the rules.

Time was allowed for any individuals present to offer oral testimony on the proposed rule changes. There were no individuals that provided oral testimony.

G Damgaard advised the Board of two rules that needed revision for consistency with the proposed amendments. ARSD 20:48:20 should have a number 8 to add simulation. ARSD 20:48:07:47 should be revised to delete the last sentence of the example.
