**ORDER OF
REINSTATEMENT
OF RN LICENSE ONLY
WITH HPAP**

WHEREAS, Suzanne Lyman, R.N., CRNA (“Licensee”), is licenced to practice as a Registered Nurse and a Certified Registered Nurse Anesthetist in the State of South Dakota and holds license numbers R027317 and CR000507; and

WHEREAS, on February 7, 2007, the South Dakota Board of Nursing, (“Board”), accepted a Voluntary Surrender Consent Order, signed by the Licensee on December 18, 2006; and

WHEREAS, the Voluntary Surrender Consent Order suspended the Licensee’s licenses for an indefinite period subject to a reinstatement request pursuant to SDCL § 36-9-57, as the Board in its discretion may determine; and

WHEREAS, the Licensee made a reinstatement request, in writing, dated August 7, 2007, and personally appeared before the Board on November 2, 2007, at which time the matter of Licensee’s reinstatement request was presented to the Board. An Order Denying Request for Reinstatement was issued by the Board on November 2, 2007; and

WHEREAS, Licensee has made a second reinstatement request, in writing, dated March 13, 2008, and personally appeared before the Board on June 20, 2008, at which time the matter of Licensee's request for reinstatement was presented to the Board. The Licensee presented documentation, including letters of recommendation, a letter dated May 10, 2008, from the Health Professionals Assistance Program ("HPAP") director, and a letter from her HPAP group. Licensee answered questions of the Board; and

WHEREAS, the Board has considered the Licensee's renewed reinstatement request, the statements and documents provided by the Licensee, the previous Orders, and Licensee's own testimony, and being fully advised in the premises;


NOW THEREFORE, IT IS HEREBY ORDERED:

1. That the Board has jurisdiction over the person of the Licensee and the subject matter of this Order.
2. That the Licensee's license to practice as a registered nurse in the State of South Dakota shall be reinstated for practice as a registered nurse only.
3. That Licensee's license to practice as a Certified Registered Nurse Anesthetist remains under Voluntary Surrender.
4. That the Licensee is hereby mandated into continued participation in the Health Professionals Assistance Program ("HPAP"), with duration and terms to be set by the HPAP program.
5. That Licensee shall have restricted access to narcotics as shall be

determined and monitored by HPAP. All monitoring conditions shall be set by HPAP, and Licensee shall fully comply with those terms and conditions.

IT IS HEREBY ORDERED that the above Order for Reinstatement of R.N. License Only With HPAP was adopted by the South Dakota Board of Nursing on the 20th day of June, 2008, by a vote of 7-0.
