REPORTS

FINANCIAL REPORTS were presented by Business Manager Robert Garrigan based on previously distributed spreadsheets. A summary of Fiscal Year 2012 and the budget for Fiscal Year 2013 were reviewed.

1ST QUARTER NCLEX REPORT AND NEDDs UPDATE: S. Orth shared that the SD NCLEX-RN pass rate was 87%, the national rate was 91%; the SD NCLEX-PN pass rate was 93%, while the national rate was 83.7%.

LEGISLATIVE REPORT: Recent legislation pertinent to healthcare across the country was discussed.

- AL SJR 83 – Creates an Interim Study Committee to review the feasibility of delegating to trained school personnel the authority to administer insulin and glucagon to students with diabetes
- TN SB 1935 – Establishes requirements for the supervision of nurses and physician assistants by certain physicians when engaged in interventional pain management
- VT SB 236 – Allows the signature of an APRN certified as a nurse practitioner or nurse midwife to be used whenever the signature of a physician is required
- LA HB 326 - Authorizes a psychiatric mental health nurse practitioner to execute emergency certificate for admission to a treatment facility of a minor suffering from mental illness or substance abuse
- DE HB 238 - Simplifies the process for a military spouse applying for reinstatement; six-month temporary license or permit while the application for endorsement is being processed

NCSBN POLICY PERSPECTIVES was provided as an informational piece.

CENTER FOR NURSING WORKFORCE: L. Young reported that at the Governance Council meeting held June 13, 2012, Strategic Initiative Tactics and Outcomes for FY 2010-2012 were updated. The Minutes were distributed.

SD ACTION COALITION Executive Steering Committee met May 24, 2012 and again July 9, 2012; Minutes of both of these meetings were provided to Board members. The purpose statement has been drafted: "To develop and prepare nurses to provide leadership resulting in high quality, patient-centered care in South Dakota by effectively implementing the Institute of Medicine's recommendations on the Future of Nursing."

NURSE AIDE TRAINING PROGRAM CHANGES: S. Orth reported that reorganization at the national level within American Red Cross resulted in changes with training programs and requirements. The Board will approve nurse aide training programs that use the "American Red Cross curriculum" only if specific conditions are met, and notified facilities by mail March 30, 2012 that as of July 1, 2012, facilities using the Red Cross curriculum must submit specified documents to be reapproved. Outdated materials are being removed as curriculum options.

HEALTH PROFESSIONALS ASSISTANCE PROGRAM: Maria Eining, HPAP Director, met with the Board to discuss the Service Committee meeting held May 22, 2012 and other matters of interest to both organizations.

INSTITUTE OF HUMAN BECOMING: D. Berkland and G. Damgaard attended this conference featuring nurse theorist Dr. Parse. G. Damgaard reported that her article "High Altitude Leadership and the Human Becoming Leading-Following Model: An Executive Director's Perspective" will be published in *Nursing Science Quarterly*, October 2012.

ATTORNEY / INVESTIGATOR CONFERENCE: K. Tinklenberg attended the meeting in Fort Lauderdale FL. According to the featured speaker, cheating and workplace theft are prevalent across the country. A case study of an individual diagnosed with bipolar disorder was presented by a police psychiatrist. A high percentage of individuals with addictions also have bipolar disorder, which requires medication for treatment; the nurse using such medication may have the bipolar disorder under control, but may be working impaired. In North Carolina, a criminal background check is required with reinstatement of licensure.

NCSBN IT: E. Matthies and R. Garrigan provided a report on the conference they attended in Minneapolis.

NCSBN EXECUTIVE OFFICERS: G. Damgaard reported on the summit held June 18-20, 2012 in Idaho. Social media, privacy issues, and related Constitutional rights, federal legislation, and court legal decisions were discussed.

TAKING THE LONG VIEW NURSING WORKFORCE CONFERENCE: L. Young reported on the conference in Indianapolis. According to the featured speaker, nursing workforce supply is growing, but is not expected to be sustainable.

OPEN FORUM – NO ONE REQUESTED THE OPPORTUNITY TO ADDRESS THE BOARD

ENVIRONMENTAL SCAN items were provided for information purposes; highlights were briefly discussed.

COUNCIL OF STATE GOVERNMENTS: The CGS Resolution regarding telehealth was reviewed; the resolution was adopted May 20, 2012 at CSG's National Leadership Conference in LaQuinta, California.

GOVERNOR CREATES PRIMARY CARE TASK FORCE Press Release from the office of Governor Daugaard – "Expanding the educational capacity to train more primary health care providers for rural areas of South Dakota" is the focus; Robin Peterson-Lund CNP, BON APN Advisory Committee member, has been named as a member of the governor's task force.

NATIONAL LEAGUE FOR NURSING INITIATED LEGAL PROCEEDINGS – In a letter dated February 7, 2012, NLN provided an update regarding the litigation that was initiated in June 2011.

UNFINISHED BUSINESS

DIABETES VIRTUAL NURSE PILOT STUDY: The Virtual Nursing Care for Children with Diabetes in the School Setting project continues to progress according to schedule. Participating in the research project are 29 children in 19 different schools throughout the state, working with virtual nurses at two different hubs. Continued support of the project is planned through the 2012-2013 school year for currently participating schools. Additional grant funds from South Dakota Department of Health are expected to sustain the project after NCSBN grant funds end. Much has been learned about the challenges involving required technology.

MEDICATION ASSISTANTS REGISTRY: To begin a registry of Medication Assistants and Dialysis Technicians, the Board must have statutory authority to allow for promulgation of rules. Board staff recommends that a Legislative Research Council (LRC) opinion be sought to determine whether SDCL 36-9-21 needs to be amended to allow for registration of specific categories, and if so, Board staff proposes the following: (36-9-21.) Promulgation of rules by board. The Board of Nursing shall promulgate rules pursuant to chapter 1-26 pertaining to:

(DRAFT) The registration of medication assistants and the disciplinary proceedings of registration; training requirements; supervisory requirements by a licensed nurse; tasks that may not be delegated by a licensed nurse to a medication assistant.

The registration of dialysis technicians and the disciplinary proceedings of registration; training requirements; supervisory requirements by a licensed nurse; tasks that may not be delegated by a licensed nurse to a dialysis technician.

MOTION: D. Soholt moved that the South Dakota Board of Nursing authorize Board staff to move forward with the process to amend 36-9-21 to develop a registry for unlicensed categories of care team members for which the South Dakota Board of Nursing has training requirements.

APRN CONSENSUS WORKGROUP: Minutes of the May 25, 2012 meeting were distributed. Via teleconference, four North Dakota licensed Certified Nurse Practitioners provided an overview of their state legislative process; 2011 legislative changes to North Dakota laws provided plenary practice for CNPs and no requirement for collaboration or supervision by a physician; the changes removed Collaborative Agreements for prescribing drugs and eliminated the need to write scope of practice protocols/documents describing their practice. Among the next steps planned, G. Damgaard and L. Young will work with the American Academy of Family Physicians (AAFP) to set up a World Café to bring together interested family practice physicians and NPs to discuss opportunities and challenges. Input will be sought from experienced CNPs in South Dakota.

JOINT BOARD ANNUAL MEETING: The next 2012 Board of Nursing meetings will be held September 18-19 & November 15-16. The Board of Medical & Osteopathic Examiners is scheduled to meet November 28, 2012. To accommodate the Joint Boards Annual meeting, a quorum of Board of Nursing members could be available in person and/or via teleconference on November 28 – or – the Board of Medical and Osteopathic Examiners could be invited to participate during the Board of Nursing’s September meeting.

CNP ISSUES: L. Young and G. Damgaard discussed the status of a Collaborative Agreement between Denton Combs, CNP and James Schaeffer, MD, which was approved temporarily by the Board of Medical and Osteopathic Examiners with the modification that Combs is to identify himself as a Family NP, and with the stipulation that this matter is to be considered at the next Joint Board meeting.

NEW BUSINESS

LAKE AREA TECHNICAL INSTITUTE: The Board received the announcement that Robin Brown has resigned, and Patricia Foley, MS, RN is the new department supervisor for the LPN program.

DAKOTA WESLEYAN UNIVERSITY: Communications were received from Adele Jacobson, Administrative Chair, announcing that DWU Board of Trustees voted in March 2012 to change the associate nursing program degree from an Associate of Arts (AA) to an Associate of Science (AS), and the RN-Bachelor of Arts (BA) to a RN-Bachelor of Science (BS), and that Gloria Thompson retired as AS Nursing Program Director; long time faculty member Wyonne Kaemingk is assuming the position.

OGLALA LAKOTA COLLEGE: S. Orth and J. Larson conducted the site visit May 2-3, 2012. Joan Nelson, Director of the Nursing Department, was present to address the Board. Program strengths and recommendations for improvement are outlined in the survey report; a summary was also reviewed. J. Nelson described the school’s new facilities. Struggles within local communities affect students; the school takes that into account and provides opportunities to prepare them for the courses. About 92% of students are Native American. To help them to be more successful, all students are required to be CNAs; the school pays the fees, and two faculty members are CNA instructors. It is recommended that in the site visit report terminology, “Recommendations” be replaced with “Requirements”.

MOTION: K. Possehl moved that the South Dakota Board of Nursing grant continued Full Approval status for the ADN Program at Oglala Lakota College, with the expectation that recommendations from the site visit team will be in compliance within one year.

WEBSITE REQUESTS: Direction regarding a policy statement was sought. In keeping with the state’s policy, a statement such as “Your request was reviewed and it does not meet the core mission of the South Dakota Board of Nursing” will be the standard response.

LICENSURE LIST Policy: A request was received from Verisys Corporation to revise Board policy to allow release of license rosters to credential verification organizations. Attorney K. O'Connell's research determined that the Board's policy regarding public access to nursing licensure information is compliant with current law. Board policy (established April 2002, revised April 2007) states: Requests for mailing labels or lists will be granted only for those individuals/organizations that can demonstrate that the purpose for the information is for educational, research, or military use. The Board shall not release licensure database information to individuals or organizations performing credentialing or licensure verification services. The only exclusion to this policy is the release of licensure database information to:

- the National Council of State Boards of Nursing for participation in NURSYS;
- other government or state agencies; and
- pharmaceutical companies or their third party agencies for the purpose of meeting Food and Drug Administration (FDA) requirements through the Prescription Drug Market Act (PDMA) for Certified Nurse Practitioners and Certified Nurse Midwives.
