**ORDER OF
REINSTATEMENT
WITH PROBATION**

Licensee

WHEREAS, pursuant to a voluntary surrender consent order dated , November 6, 2001, the Licensee's license to practice as a certified nurse practitioner in South Dakota shall be suspended for an indefinite period. It was also provided that Licensee may petition for reinstatement following her resolution of all issues with law enforcement resulting from her conduct (including the completion and discharge from any sentences and/or probation) and at least one year's successful completion of probationary monitoring as an registered nurse, if Licensee received the reinstatement with probation. and

WHEREAS, Licensee made a reinstatement request in writing and was personally present at the Board of Nursing's September 18, 2003, meeting at which time the matter of Licensee's reinstatement was presented to the Board of Nursing, and Licensee and her attorney presented statements and answered questions of the Board of Nursing, and

WHEREAS, both of the Boards have considered such request, testimony, statements, documents and orders, and are fully advised in the premises;

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. That the Boards have jurisdiction over the person of the Licensee and the subject matter of this Order.

2. Licensee's CNP license is placed upon a probationary status Licensee's license to practice nursing is placed upon a probationary status, with the length of the probation to be set by the Health Professionals Assistance Program and with terms and conditions of the probation to also be set by the Health Professionals Assistance Program, which probationary terms and conditions shall be completely followed by the Licensee.


3. Further, Licensee shall at any time during the period of probation, report in person to such meetings of the Boards or to their designated representatives as directed and otherwise fully cooperate with the Boards or their representatives in the terms of this probation. Licensee's current renewal certificate will be stamped "PROBATION" during the duration of the probationary period. Licensee shall pay for all costs and expenses in carrying out any conditions of the probation.

4. If any condition of this probation is violated, the Boards may take such actions as the Boards deem necessary up to and including a total and complete revocation of Licensee's licensing rights as a CNP in South Dakota.

5. Licensee shall execute all release of information forms as may be required by the Boards or their designee.


