- 1. Call to Order and Roll Call** – K Possehl, Board President called the meeting to order at 9:01 a.m. February 16, 2017.
- 2. - 4. Financial Reports** – R Garrigan presented the Financial Report for Fiscal Year 2017 July through December and responded to Board questions.

## 5. Reports

**A) Licensure and Operations Report** – E Matthies presented the February 2017 licensure and operations report. At time of print the report reflected 17,806 licensed Registered Nurses (RN), 2,567 licensed Practical Nurses (LPN) and 1,420 licensed Advanced Practice Registered Nurses (APRN) in South Dakota.

**B) Certified Nurse Aide (CNA) Report** – T Stob presented the CNA 2016 Annual Report. At time of print the report reflected 10,215 actively registered CNA's and 56 active approved CNA training programs in South Dakota.

**C) Center for Nursing Workforce (CNW)** – L Young reported that the biennial workforce nursing report will be presented at the April meeting. She also provided an update on the CNW's nursing leadership development program. The CNW is partnering with EmBe and plans to graduate the first participant cohort from the Sioux Falls program in May 2017. EmBe and the CNW are now planning to offer the leadership program in the Rapid City area. The Rapid City cohort will begin in the fall of 2017 and was advertised in the Dakota Nurse Connection.

**D) NCLEX Pass Rates** – G Damgaard presented the 2016 NCLEX pass rate report. The 2016 LPN pass rate for South Dakota programs is 92.7%. The national LPN pass rate is 83.7%. The 2016 RN pass rate for South Dakota programs is 86.1%. The national RN pass rate is 84.6%.

**6. Open Forum** – K Posschl, Board President, provided the opportunity for guests to address the Board, no one requested to do so.

**7. Environmental Scan** – G Damgaard presented documents for informational purposes and answered Board questions. The 2017 Environmental Scan, published in the January 2017 edition of the Journal of Nursing Regulation was provided to Board members.

## 8. Unfinished Business

**A) Policy discussion on Unlicensed Assistive Personnel (UAP).** T Stob presented proposed changes to ARSD 20:48 to add a new section on rules that will outline the requirements for initial registration, renewal, and removal of registered unlicensed medication aides, unlicensed diabetes aides, and unlicensed dialysis technicians. K O'Connell provided a legal opinion on the removal of individuals from the registry. Discussion was held by the Board on accepting the proposed rules and whether to direct Board staff to move forward to promulgate the proposed rules.

**B) Nurse Licensure Compact (NLC) Update** – G Damgaard presented the enhanced Nurse Licensure Compact (eNLC) update to the Board. Monthly implementation meetings are being conducted by the NLC implementation group. 10 states enacted the eNLC in 2016 and 21 states are expected to introduce legislation in 2017. E Matthies presented information on the background work she has been doing with our database to prepare for these updates, and responded to Board questions.

**C) 2017 Strategic Plan** – The Board reviewed progress on the 2017 Strategic Plan.

**D) Board of Nursing Centennial Plan** – G Damgaard presented plans for the Board's 100 year centennial celebration. Artist J Jakowicz presented a medallion he created to represent the 100 years of nursing regulation. Board members shared celebration ideas including holding a ceremonial board meeting in July at the Capitol in Pierre, a day of dialog with speakers, a Governor's proclamation, and an evening banquet.

**E) Western Dakota Technical Institute** – Agenda item removed.

**F) Oglala Lakota College (OLC)** – G Damgaard provided background information on OLC’s program approval status. J Zephier, Program Director, responded to questions on OLC’s associate degree registered nurse program.

**A) Personnel** the Board moved to enter executive session, pursuant to SDCL §1-25-1(3) for the purpose of Personnel.

**B) 2017 Legislature Update** - G Damgaard presented an update on the status of Senate Bill 61 (SB 61), that updates, revises and repeals certain provisions relating to nurse practitioners and nurse midwives. SB 61 has passed both Chambers and has been sent to the Governor for signature. Senate Bill 136 (SB 136) a bill to permit and regulate the practice of licensed certified professional midwives was discussed. House Bill 1006 (HB 1006) that revises certain requirements for a public notice of a public meeting, was delivered to the Governor for signature on January 31<sup>st</sup>. House Bill 1043 (HB 1043) an act to revise certain provisions relating to the practice of pharmacy, was tabled in committee on 1/19/2017.

**C) Mitchell Technical Institute (MTI)** – MTI requests interim status for their practical nurse (PN) program. Dr. C Jarding, Program Director, presented an overview of MTI’s proposed program including documents on MTI’s administration, plans for PN faculty, curriculum development, clinical locations, and plans for students’ enrollment. Dr. C Jarding and C Grode-Hanks responded to questions from the Board.
