

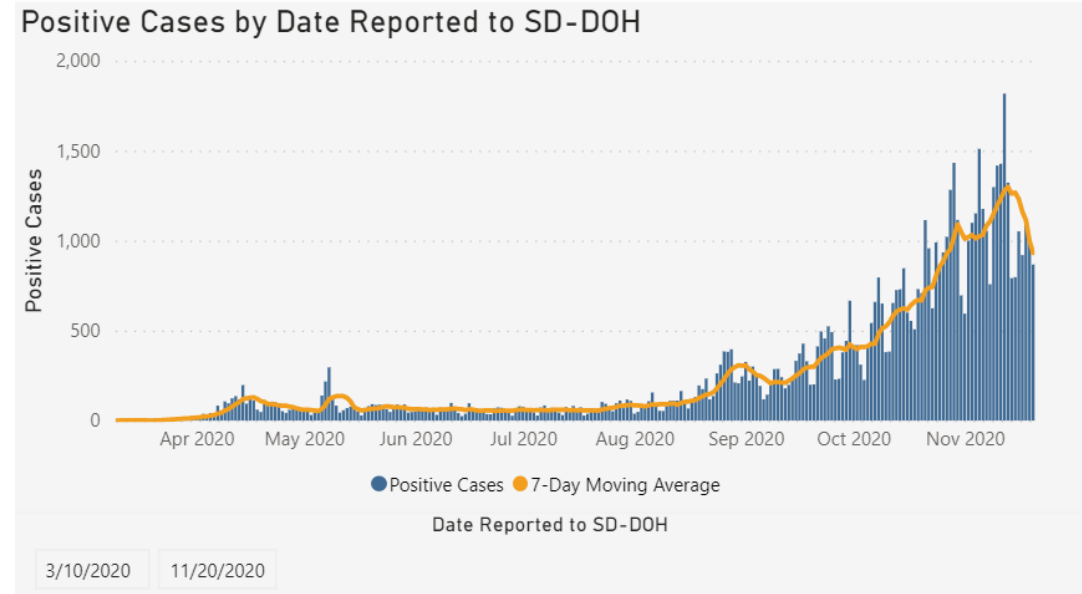

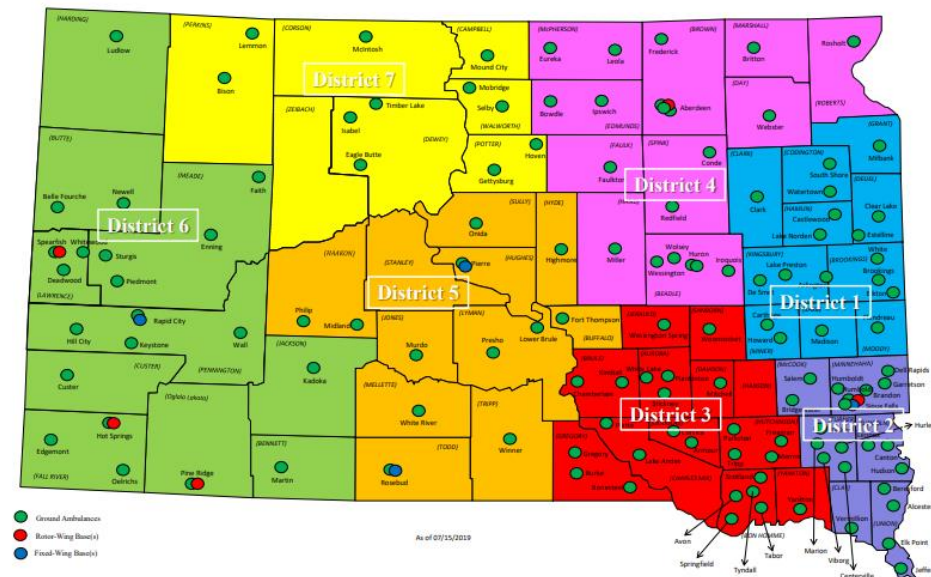

- Protect yourself and your patients as if they have COVID-19

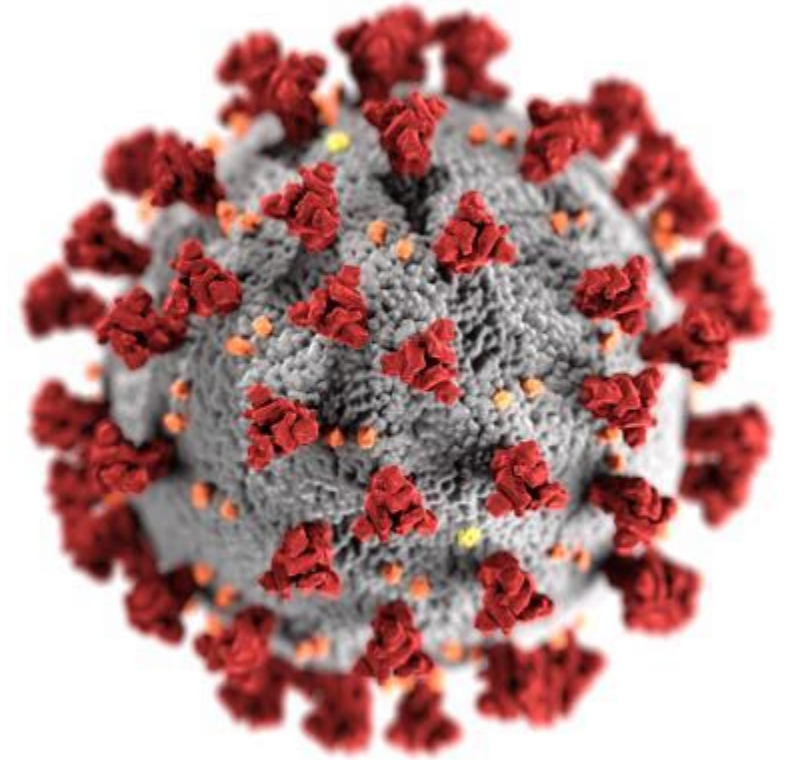

OWS/CDC contracted with 6 manufacturers to produce

Vaccination Presentations

- Early doses of vaccine will be in multi dose vials
- There will be variable vaccine storage requirements --80C, -20C, 2-8C
- Stability testing is still being conducted and storage requirements and expiration dates may change
- May be other presentations of vaccine available later: SDV, SDS

Vaccine Timeline

Pfizer

- Potential EUA filing the third week of November
- Potential for vaccine availability late the first week or into the second week of December

Moderna

- Potential EUA filing early to mid December
- Potential for vaccine availability late in December



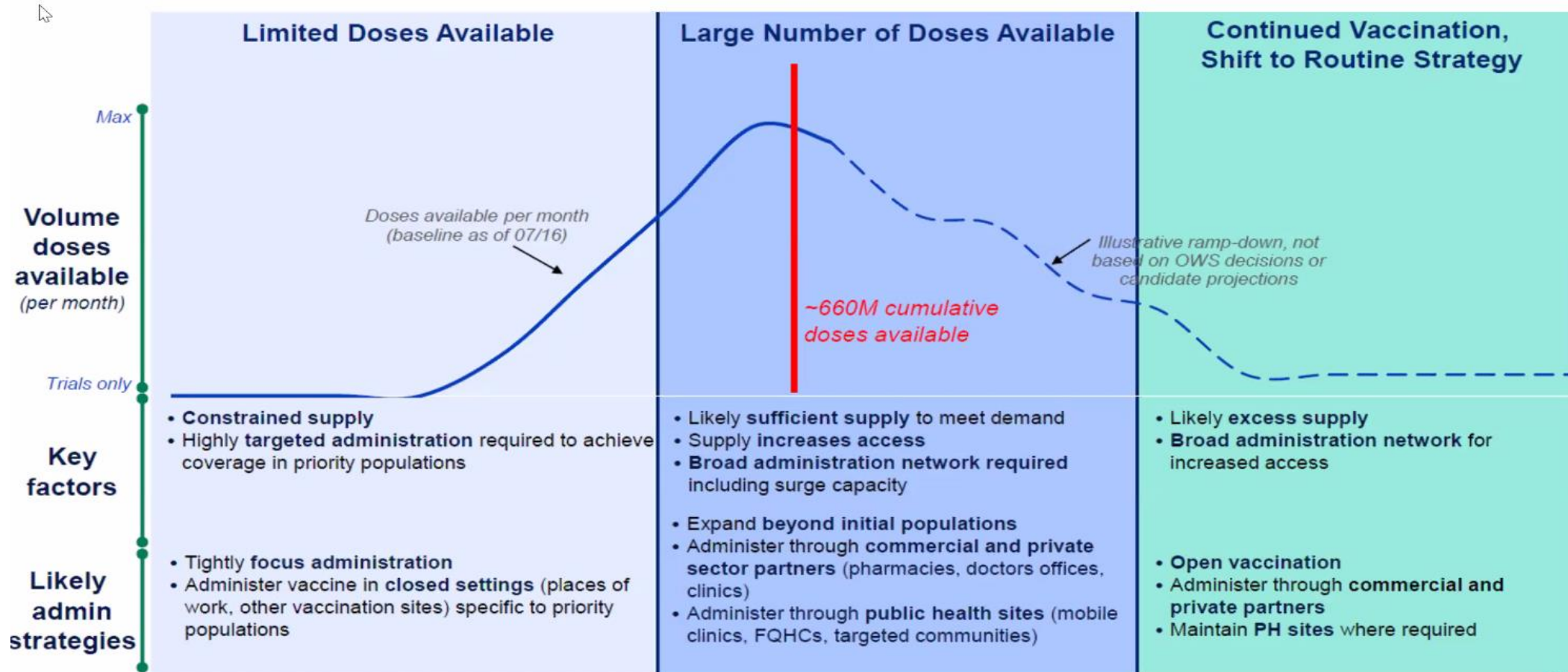
FDA/ACIP Timeline

- FDA's Vaccines and related Biological Products Advisory Committee (VRBPAC) will make recommendation on EUA two weeks after application
- ACIP will meet within 24 hours of EUA approval to consider recommendations

Vaccination Phases

Illustrative scenario for planning purposes; will be adapted based on the clinical / manufacturing information on all OWS candidates and vaccine prioritization

Distribution will Adjust as volume of vaccine doses increases, moving from targeted to broader populations reached (phased approach)

Target Populations for phase 1a

- LTC All Staff and front-line healthcare workers – direct care of COVID-19 patients
- COVID-19 Units
- ED
- ICU
- Other High Risk Floor Units (include oncology, transplant, OB, NICU)

Retail Chain Pharmacies Phase 2

- CDC Contracting directly with chain pharmacies
- Contracted pharmacies would receive a direct allocation of vaccine during phase 2
