Hand Hygiene and Respiratory Etiquette

- Before you leave, [wash your hands](#) with soap and water for at least 20 seconds or use hand sanitizer with at least 60% alcohol.
- Once you reach your destination, [wash your hands again](#) or use hand sanitizer as soon as possible.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Cover your coughs and sneezes with a tissue or use the inside of your elbow. Throw used tissues in the trash and wash your hands immediately with soap and water for at least 20 seconds or use hand sanitizer with at least 60% alcohol.



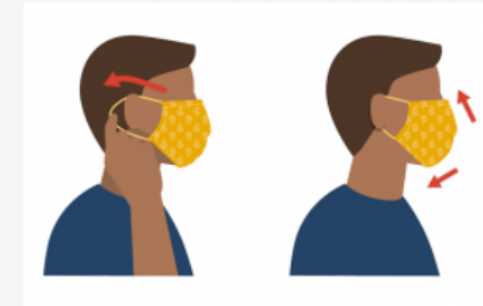
Wear a Mask

- Not alone? Wear a mask
- Driving someone in the vehicle? Wear a mask
- Wear it properly and avoid touching your face/readjusting as much as possible.
- When possible, wear a hospital grade facemask



Wear your Mask Correctly

- Wash your hands before putting on your mask
- Put it over your nose and mouth and secure it under your chin
- Try to fit it snugly against the sides of your face
- Make sure you can breathe easily
- CDC does not recommend use of masks or cloth masks for source control if they have an exhalation valve or vent



Clean and Disinfect Frequently

- Perform hand hygiene (use hand sanitizer) after touching high touch surfaces (ex: door handles, seatbelts)
- Wipe off surfaces in vehicle after transportation of patients
- Focus disinfection on the high touch surfaces
- Use an EPA List N approved disinfectant for COVID-19

Social Distance & Increase Ventilation

- When possible, seat passenger as far from driver as you can.
- Limit number of passengers to increase space between individuals.

- Set air-conditioning or heat on non-recirculation mode

COVID Positive Transports

- Communicate with the healthcare facility and patient regarding isolation or quarantine dates
 - Follow workplace policies regarding transfers, cleaning, infection control practices
 - Socially distance and keep 6 ft separation from COVID positive individuals
 - If PPE being used, training provided
