DEFAULT SUSPENSION



The South Dakota Board of Nursing met on the 10th day of February, 2021, to consider a Complaint and Notice of Hearing regarding Amy Nannemann's privilege to practice as a Registered Nurse (RN) in the State of South Dakota. Licensee failed to appear at the time and place set for hearing or otherwise contest the Complaint against her privilege to practice or contest the existing summary suspension. The Board, by a vote of 7-0, therefore accepted the facts set forth in the Complaint as true and, upon motion of the prosecuting attorney, entered a Default Suspension of Licensee's privilege to practice in the State of South Dakota.

IT IS HEREBY ORDERED that Licensee's privilege to practice in the State of South Dakota is hereby suspended.

WHEREAS, the Board have now entered a final Default Suspension following a due process formal hearing on February 10, 2021, for a final resolution of this matter.


THEREFORE, it is hereby ORDERED
