POSITION OBJECTIVE:

Serving as a Paramedic, the employee provides pre-hospital emergency medical care and as well as medical care on interagency transfers. Performs necessary daily functions (i.e. rig checks) and completes all required call reporting. Provides office administrative support (i.e. copying, filing, etc.) when not on runs.

EXAMPLES OF ESSENTIAL DUTIES:

To perform the job successfully, an individual must be able to perform each essential duty satisfactorily within their level of training.

The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions. Duties may include, but are not limited to the following:

- Serve as a Paramedic, providing emergency medical care for dispatched 9-1-1 medical and trauma calls in accordance with adopted Medical Protocols and the State adopted scope of practice.
- Provide BLS and ALS medical services and monitoring on inter-agency transfers in accordance with adopted Medical Protocols and the State adopted scope of practice.
- Safely drive ambulance in all weather conditions as well as in high-stress, emergency transport situations.
- Respond to dispatch pages for stand-by coverage as personal availability allows.
- Write accurate and detailed reports.
- Ensure that reports contain all necessary documentation required for billing and liability (i.e. signatures, ABNs, etc.)
- Perform Blood Draws for Law Informant as needed.
- Conform to policies, regulations and procedures;
- Provides office administrative support (i.e. copying, filing, running errands, getting prices quotes, etc.) when not on runs;
- Responds to monthly scheduling requests promptly and ensures coverage if swapping shifts:
- Assist with training presentations (both for in house staff and for students) could include group presentations or one-on-one practical work;
- Assist with fundraising and community outreach initiatives (i.e. EMS Week)

Other duties and responsibilities:

- Attend continuing education and refresher training programs as required by City, State or other licensing /certifying agency or organization;
 - Ensure that training requirements are met and documented for re-certification (responsibility of employee to obtain and get copies to Compliance Officer);

Represent the department while on shift on city-wide and inter-agency committees and other cooperative programs.

Maintain close liaison with fire, law enforcement and other officials of neighboring public jurisdictions and with officials of State and Federal agencies.

Perform other duties as assigned.
