Administrator's Update

Welcome to the March edition of PULSESD. The beginning of 2025 is off to a busy start, and we wish you a year of health and abundance. As of this writing, the 100th legislative session is nearing its end. This year brought forth several EMS bills raising awareness of our profession and highlighting future discussions focused on sustainable solutions.

I wanted to share some exciting news occurring within the Department of Health (DOH). Effective February 24th, 2025, internal restructuring combined the Office of Rural Health with the Office of EMS and Trauma. This new structure will also include our newest initiative in creating a Stroke System of Care. Over the past several weeks and the foreseeable future, our new office will focus efforts in establishing a new office name, renewed strategic purpose and goals for 2025. My position has changed as I will now serve as the Deputy Division Director for the Division of Healthcare Access and overseeing not only our Office of EMS and Trauma but also the Office of Rural Health teams.

In alignment with the Department of Health's strategic vision, "Every South Dakotan Healthy and Strong," our combined office structure will focus intently on working with vested and visionary partners seeking a brighter future and ensuring quality and timely access to healthcare for every South Dakotan. This includes reimagining EMS 2.0.

We've been blessed across this great state to have such a dedicated and passionate pre-hospital workforce. We've embraced the transformative pioneering initiative Telemedicine in Motion which has seen over 1600 activations connecting EMS personnel in the field with paramedics, nurses, and board-certified ER physicians with Avel eCare, and our Regional Service Designation grants have distributed several million dollars towards the advancement and sustainability of EMS.

As we look into the future of our new office structure, our team plans to meet with EMS leadership, rural health clinics, facility administration, medical providers, and local leaders dedicated to having meaningful conversations around rural health needs, identifying healthcare gaps, and embracing future change.

Thank you for your continued dedication and we look forward to working together well into the future.

Emergencies can strike without warning, and when they do, help may not always be nearby. 







SDAHO Award Additional Funding for EMS Regional Service Designation Grant

The South Dakota Association of Healthcare Organizations HRET is excited to announce they have been awarded the Regional Service Designation Grant. Funding is provided by the American Rescue Plan Act, aimed at supporting Emergency Medical Services (EMS) across South Dakota.

The goal of the project is to Successfully implement a statewide interfacility transfer software platform for hospital and ambulance services by the end of November 2026.

SDAHO is partnering with Dell Rapids and Sioux Falls (Patient Care) Ambulance Services, focusing on improving the interfacility transfer process. This project will create a single portal where neighboring ambulance services can view and select available transfers.

The first phase of this grant was awarded to SDAHO in April 2024, for \$50,000. The first three months of this project focused on planning, identifying key stakeholders, holding listening sessions, and selecting software.

The most recent award is part of the second phase of funding, with SDAHO being awarded \$500,000.

The initiative stems from the <u>Regional Services Designation</u> analysis of 2023, which offered \$7.5 million for EMS providers to enhance their services.

South Dakota Health Link Data Management

 - ♦ Geographic trends across cities, townships, stations, and zones.
 - ♦ Intervention counts and success rates.
 - ♦ ePCR validation scores and overall data entry quality.

Billing System Optimization

- North Star Solutions will assess and enhance current billing practices to improve financial efficiency.
- Our team will collaborate with your agency and billing provider to develop optimized workflow solutions.
- We will also analyze insurance, Medicare, and Medicaid reimbursement processes to ensure your agency receives the maximum revenue it is entitled to.

Revenue Stream Diversification

- North Star Solutions, in partnership with CHWSD, will assist agencies in establishing a Community Health Worker (CHW) program.
- We will provide support in the creation of an ambulance tax district to secure sustainable local funding.

A message from the South Dakota Board of Medical and Osteopathic Examiners

As 2025 progresses rapidly, the busy legislative session has concluded. Here's a brief update on the bills passed affecting EMS licensees in South Dakota:

- HB 1014. In response to unforeseen consequences arising from the requirement that all EMS levels have a
 medical supervisor, this bill restored the supervision requirements for EMRs and EMTs to their status prior to July
 1, 2024. HB 1014 included an emergency clause, making it effective immediately once it received all the
 necessary signatures. All signatures were received in February.
- **HB 1099.** Modified the statutory language for the community paramedic endorsement to allow for both education and exam routes to obtaining the endorsement, this mirrors the provisions outlined in the critical care paramedic statute. This change will take effect on July 1, 2025.
- **SB 77.** This bill will update the terminology in statute and rule from ambulance drivers to ambulance operators. This change will take effect July 1, 2025.

EMS Advisory Council: Who, what, when, where, and why?

Who: Per SDCL 36-4B-37, the EMS Advisory Council is comprised of

- One EMT-B
- One EMT-I/85, EMT-I/99, or AEMT
- Two paramedics
- One physician trained in emergency medicine

What: The EMS Advisory Council assists the Board and makes recommendations in matters related to licensure, EMS practice, education, continuing education, investigation, discipline, and rulemaking.

When and Where: The EMS Advisory Council meets a minimum of twice per year and as necessary to conduct business. Meetings are virtual and open to public attendance. Details about the meetings can be accessed in the agenda available at https://www.sdbmoe.gov/ under "Board Info" section and "Advisory Councils" option from the dropdown menu. Agendas are posted at least 72 hours prior to the meeting.

Why: Each profession overseen by this Board has an Advisory Council. These councils serve as a valuable resource for the Board, as they consist of experts in their respective fields.

Cardiac Ready Community & Campus Program

During a cardiac emergency, every second...every minute that passes without CPR or AED use can mean the difference between life and death. It can take an ambulance 30 minutes to respond in South Dakota's more remote areas.



The <u>Cardiac Ready Community (CRC) Program</u> helps educate, equip, and empower local community members to be better prepared and more confident in helping someone experiencing a cardiac event before the ambulance arrives. Communities are prepared to provide tools and resources to improve cardiac emergency response, AED access, and heart health education.

WHY GET INVOLVED

Cardiac Ready Communities have increased survival rates through widespread CPR & AED training. There is enhanced AED availability in key locations, and this improves response times and strengthens EMS partnerships. The CRC Team works together to create a system of care where all community members come together to increase access and save lives.

HOW TO JOIN

Communities and campuses can start by building a local team, identifying AED and CPR training needs, and working toward recognition as a Cardiac Ready Community or Campus. **Get Started Today!** Reach out to Stephanie Hanson, SD Department of Health Cardiac Ready Community Lead or submit your **Letter of Intent** and we will reach out to you.

As of March 2025, 6 communities have been designated, 4 colleges campuses are becoming Cardiac Ready Campuses, and 9 communities have signed their letter of intent of becoming a CRC. **Your community is a heartbeat away from saving lives – assemble your CRC Team today.**
