COMMUNITY HEALTH PRIORITIES DISCUSSION (Cont.)

- Reducing the Burden of Disease
 - Problem: Spread of STIs (particularly syphilis and congenital syphilis), risky behaviors (drug use, alcohol use, unprotected sex), capacity of disease investigation (contact investigation and case management), penicillin shortage
 - Possible Solutions: Prevention and early detection of STIs, provider education, patient education, promote safe sex practices, education on impact of STIs and long-term effects, public health campaigns, expand screening and treatment practices, additional disease investigation positions, improved technology to notify exposed contacts
 - Problem: Prediabetes/diabetes, limited physical activity and nutrition funding, built environment (culture around food, long winters, limited access to physical activity, limited access to fresh fruits and vegetables)



- Possible Solutions: referrals to nutritionists, provider management (medication vs. behavior modification)
- Enhancing Environmental Infrastructure to Support Health
 - Problem: food insecurity, food sovereignty
 - Possible Solutions: mobile food units, backpack programs, community gardens, cooking classes utilizing community garden produce and food banks, connecting people to WIC enrollment, provider education, integration of services/resources, breastfeeding promotion and support
 - Problem: Data sets have certain limitations
 - Possible Solutions: integrated data, master person index across agencies, single sign on across state government
 - Problem: internet/broadband access, cellular phone access and cellular service
 - Solution: remote patient monitoring, telehealth services, personal device vs.
 clinical setting/offering, community pod offerings, school-based telehealth
- Maintaining Health Services and Care Quality
 - Problem: healthcare professional shortages (not only a rural issue), workforce burnout,
 COVID shifted care coverage
 - Possible Solutions: burnout support, childcare for 12-hour work shifts
 - Problem: professional education (time, cost, location)
 - Possible Solutions: Virtual learning, remote job training opportunities, unite the workforce, do the apprenticeship in your own community
 - Problem: Certification/Licensure
 - Possible Solutions: ensure professionals are working at the top of their certification and/or license
 - o Problem: reimbursement challenges
 - Possible Solutions: broaden the payer base
 - Problem: keep students in state, planning for retirement wave
 - Solutions: tracking trends for the future of healthcare workforce
 - Problem: Retaining professionals in their practice
 - Possible Solutions: Identify characteristics of long-term employers and highperforming organizations – Plan to manage turnover.
- Advancing Health Literacy/Efficacy using Culturally Appropriate Strategies
 - Education
 - Cultural Awareness
