Director's Update

We are a month away from closing out another year. Time seems to go by so quicky in the business of life. I hope each of you have an opportunity to spend time with friends and family during the holiday season reflecting on the many blessings in life and remembering those who have gone before us.

This year has been incredibly busy for our team. During the legislative session, Governor Noem advocated for and the SD legislature approved nearly \$20 million for Emergency Medical Services. In June, the Department of Health conducted a reorganization moving the EMS Program from under the Office of Rural Health to form a new office - The Office of EMS and Trauma. South Dakota was the third state to adopt the National EMS Information System version 3.5 upgrade. And recently, our office underwent a three phased strategic planning process with the final version to be completed by year's end.

In addition, we partnered with the Avel eCare Medical Group and are well underway of creating the first of its kind - Telemedicine in Motion - a transformational endeavor to bring telemedicine in the back of ambulances. We've ordered 345 LIFEPAK monitor/defibrillators to be placed in every licensed ambulance in the state and we are in the final stages of securing a contract for our Regional Service Designation initiative with Healthcare Strategists - a consulting firm out of California.

On a national level, we advocated for various EMS initiatives at the National Association of State EMS Officials annual and mid-year meetings, NASEMSO Board meetings and retreats, and took leadership roles in chairing the NASEMSO Western Plains Region meetings.

As I glance back at our full calendars and the tremendous amount of work invested in EMS, I believe wholeheartedly all the work will be worth the effort. I can say this in confidence knowing that the work supports the brave men and women serving our citizens day in and day out.

New NEMSIS V3.5 ePCR Form Going Live January 1st, 2023

All <u>Direct Users</u> of the DOH's ImageTrend Elite ePCR system will be moved to the new NEMSIS Version 3.5 ePCR form on or before January 1st, 2023.

All <u>Third-Party Users/Vendors</u> will have until the end of the first quarter of 2023 to transition/import V3.5 data into our repository – and import data going back to January 1st, 2023.

If your service is ready to move to the new form now (or prior to January 1st), please let Lance know and we will turn on 3.5 and inactivate the current/old ePCR form.

If you would like to look at the new form or do practice charts before your transition, instead of entering your username and password you will enter:

Username: Training3
Password: Training@2

Telemedicine in Motion

Many of you are aware of the partnership between the Department of Health and Avel eCare Medical Group. For the past several months, we have gone from first time introductions to what feels like an extended family. I have been incredibly impressed by Avel's team, dedication, and commitment to this partnership.

As of this writing, we are well underway with our five pilot sites. Dell Rapids and Kimball Ambulance each have equipment installed and are live. Humboldt and Sturgis have already undergone implementation calls and will be live in the next few weeks.

As a reminder, ambulance service directors were emailed a short survey to complete indicating their level of interest in this pioneering initiative. We are currently seeking early adopters during our phase one approach with the aim of having 60 ambulances live by May 31st, 2023.





South Dakota Announces Next Generation of EMS Services

PIERRE, SOUTH DAKOTA: The South Dakota Department of Health (DOH) is pleased to announce the launch of a new telehealth partnership between DOH, Emergency Medical Service (EMS) Agencies, and Sioux Falls-based telemedicine provider, Avel eCare. This initiative will use telemedicine to transform the delivery of care provided to patients throughout the state. During the 2022 Legislative session, Governor Noem requested, and the South Dakota Legislature approved, three funding initiatives to infuse up to \$20 million into EMS in South Dakota. Telemedicine in Motion is one of the three initiatives, with a budget of \$1.7 million dollars. Avel eCare was selected after a nationwide Request for Proposals process.

"Telemedicine in Motion will connect EMS agencies throughout South Dakota to board certified Emergency Physicians and registered nurses via telemedicine from Avel eCare," said Joan Adam, DOH Cabinet Secretary. "Many of our EMS agencies experience long distances to travel, when our residents need care the most. Through Telemedicine in Motion, Avel will provide virtual triage and consulting services to EMS professionals through two-way audio and video in the back of the ambulance. This initiative will improve the coordination of care between our EMS providers and hospitals."

The partnership with Avel offers each participating licensed ground ambulance service in South Dakota a telehealth solution that will include the necessary hardware, software, installation, training, support, and telehealth subscription for professional consulting services at no cost. Avel will work directly with EMS providers on the initial installation and continued support. The goal is to support the retention and recruitment of EMS workforce with access to on-demand support.

"Avel eCare is honored to partner with the South Dakota Department of Health to deliver telemedicine services to our EMS agencies across the state " commented Becky Vande Kieft, Vice President and General Manager of Emergency Services at Avel eCare. "We have deep roots in South Dakota, and our team of clinicians look forward to helping these EMS professionals - our friends and neighbors - manage patient care and promote high quality outcomes while in transit."

The communities of Dell Rapids and Humboldt have already received equipment installation and are undergoing testing this week. The DOH and Avel aim to have at least 60 EMS agencies up and running with virtual telemedicine capabilities by next spring.

"This investment in the future of EMS in South Dakota ensures a seamless care experience in the most critical times," said Secretary Adam. "The model of care we established through this public-private partnership is unprecedented. This statewide initiative is the first of its kind and is a pioneering opportunity to advance care to patients and support pre-hospital professionals."

Telemedicine in Motion: EMS is a new program designed to provide telemedicine services to EMS agencies throughout the state of South Dakota. Agencies who participate will now be able to install an iPad in the back of their ambulance and use the tool to call Avel eCare's emergency medicine experts who are based in Sioux Falls. Now, whenever the EMS professionals need help, they can quickly call and interact with doctors and nurses while in transit. This partnership was made possible thanks to Governor Noem's leadership and call for increased funding to support local EMS agencies and the communities they serve. This program is a first-of-its-kind in the nation, and will help sustain the future of EMS in our state.

Rural Healthcare Facility Recruitment Assistance Program

The Rural Healthcare Facility Recruitment Assistance Program provides a \$10,000 payment to eligible health professionals who complete a three-year, full-time service commitment. The health professional must enter into a three-way contract between the employing facility and the state. Eligible facilities must be located in a community with a population of 10,000 or less. Applications must be submitted by employing facility with a limit of 3 participants per employing facility.



2023 Homeland Security Grants—Open Application Period

Applications for Homeland Security grant funding are being accepted from January 1 - February 17. The South Dakota Office of Homeland Security provides grant funding through an application and award process to a variety of organizations including fire departments. Funding will be awarded for one-time projects that have a connection to Homeland Security by providing protection against terrorism threats.

Examples of allowable expenses include for public or private/non-profit Emergency Medical Services include P25 radios compatible with the State Radio system, pagers for 1st responders, radio signal amplifiers, repeaters, specialized medical equipment, training and exercises.

Awards are competitive and will be based on recommendations of regional review committees. Funding for projects will become available on or about Sept. 1, 2023. Award agreements will be generated after funding becomes available; projects cannot start before the award date.

EMT Recertification Reminder

SD Certified EMTs who will expire on March 31st, 2023 can log into their E-Licensing account now thru the end of March to recertify.

<u>IMPORTANT NOTE:</u> If the EMT fails to renew prior to his/her expiration date (their SD EMT Certification is expired), the person will have to go through the Federal (FBI) and State (SD DCI) Criminal History Background Checks (fingerprinting), before we can reinstate their SD EMT Certification.

We require EMTs to have a minimum of 20 hours of EMS Continuing Education in different topic areas:

- Airway, Respiratory & Ventilation 1.5 Hours
- Cardiovascular 6 Hours
- Trauma 1.5Hours
- Medical 6 Hours
- Operations 5 Hours
- Plus CPR for Healthcare Providers

If you will be renewing your SD EMT Certification using National Registry, be sure you upload your NEW National Registry Card in your application and not your expiring National Registry Card.

If you will be renewing your SD EMT Certification using Continuing Education Hours (not National Registry), please be sure you have the required hours before you submit your application, or your application will be rejected.


NOTE: Renewing your National Registry Certification <u>does not</u> automatically renew your State EMT Certification. Everyone has to log into their E-Licensing account and apply for their SD EMT Certification.
