## OVERVIEW

Pursuant to [SDCL 25-1-13](#), any minor applying for a marriage license must be at least sixteen (16) years old and have obtained a circuit court order stating that the marriage is voluntary and in the best interest of the minor applicant, along with written, notarized consent by two parents or the guardian of the minor.
